## Making progress

Overlooked in most news coverage late last month was a definite win for health care expenses of U.S. citizens.

Authored by Congressman Steve King (R-IA), the bill passed in the House without much fanfare. Essentially, it caps medical malpractice awards for non-economic damages at a maximum of \$250,000.

Several physicians who were consulted about the bill said this single action would lower costs to consumers through insurers and health care providers. A first move in tort reform, end-users of health care insurance could save as much as 30%.

This action will save millions of dollars in frivolous lawsuits or excessive damage claims. Now it's up to the Senate.

# **Repeal dysfunction**

Massive unpopularity of the Affordable Care Act (Obamacare) decimated the Democrat Party after 2010. But they want to keep the legacy; just "tweak" the ACA with help from the *other party*. Lie upon lie has been forgotten; all is warmly bipartisan.

Republicans, meanwhile, having been elected to office by conservative Tea Party movement-driven wave elections in 2010 and 2014, slept through the entire destruction of the opposition party, even forgetting who their "opposition" was. They sat for seven years without concocting an Obamacare alternative plan (like returning control to the *free market*) or attempting to starve the offensive health insurance beast.

According to *Ballotpedia*, since Obamacare became law in March, 2010 Democrat seats in the U.S. Senate have fallen from 55 to 46. Democrats were also decimated in the U.S. House, falling from 256 to 194. Electoral damage caused by the illegal, unconstitutional Obamacare law was deeper at the state level, voters punishing Democrats severely for their assault on taxpayers and the health insurance market. Democrat governorships fell from 28 to 16 and elected Democrats in state legislatures suffered catastrophic losses of 958 seats.

Largely due to Obamacare, the eight oppressive years of the Obama Regime cost Democrats 1,042 federal and state elected offices. The voters punished the offenders.

Costs of the radical changes executed by a major political party, in their overreach and forced takeover of one-sixth of the U.S. economy, are obvious, but ignored by Republicans. You won't hear them use these facts to defeat Democrats or pin responsibility for the severe ACA catastrophe on their chests. The GOP has been given a gift, but they cannot explain it and certainly don't understand it, so they don't use it.

In their acute Obamacare repeal dysfunction, the GOP cannot even explain why Medicaid needs to be scaled back and states weaned off this expensive federal teat.

In 1966, when it was created, Medicaid enrollment numbered 4 million. In 2007, Medicaid was provided for 50 million people. Today, in 2017, Medicaid serves 70.3 million Americans. It's no longer a program for the poor, disadvantaged and disabled; the parameters are ever-widening and staggering waste in the system is ignored.

Republican Party leadership and most elected party membership have no desire to abandon Obamacare. Promises made on numerous campaign trails across our nation since 2010 have no weight at all. As with other pledges made to sustain their careers, after elections are won, all recollection disappears. Repeal of Obamacare, no different.

On July 20, HHS scored Senator Ted Cruz's (R-TX) amendment (the Consumer Freedom Option) to the Senate Obamacare replacement (BCRA) very favorably. They found that, under Cruz's amendment, 2.2 million more people would be covered. Premiums under the Consumer Freedom Option would drop substantially. Those who choose to stay on Obamacare can; those who want a cheaper plan, go buy it.

Republican Senators who refuse to vote for repeal of Obamacare in 2017 but voted *for it* in 2015 are Shelley Moore Capito (WV), Rob Portman (OH), and Lisa Murkowski (AK). These three senators who say "no" today, but said "yes" when they knew Barack Obama would veto the Obamacare Repeal Bill of 2015, are dishonest; they lied to their constituents.

When there's a chance to free the American people from the shackles of Obamacare they cower and consult with their lobbyist friends in the health insurance industry. This is really who they work for; donors are everything. Constituents are only there for votes, once every six years.

Leaving Obamacare in place is not an option; not for those promised and not for those who suffer under the mandates.

President Trump's bill-signing hand is all warmed up. Republican senators need to fix their dysfunction and repeal Obamacare.
