### A devious plot fails

## End of the inquisition

At a little after 4:00 p.m. on Saturday, October 6, 2018 the U.S. Senate voted 50-48, confirming Judge Brett Kavanaugh as the 114th justice on the U.S. Supreme Court. A weary nation heaved a sigh of relief, anxious for an end to the perverted attacks from a dishonest media and its depraved progressive allies.

Democrats had done their best to find anyone who would come forward with allegations against Judge Kavanaugh. The willing accusers would be paid for their trouble and attorneys would be provided. If someone knew Kavanaugh personally that would be a plus. As Senate Minority Leader Chuck Schumer threatened on July 9, the day Kavanaugh was nominated, he would stop Kavanaugh "by any means necessary."

Of the three "accusers" who accepted the offer, Christine Blasey Ford, PhD was the most believable. Her letter had reached Sen. Dianne Feinstein (D-CA), ranking member of the Senate Judiciary Committee, in plenty of time to assemble a plot for the eleven hour destruction of Kavanaugh.

Democrats failed to break him during questioning, but the inquisition of Kavanaugh for alleged sexual abuse began before the letter's release. Ford was flown from California to DC and the circus began. If the unrelenting character assassination failed to force Kavanaugh to withdraw, or Trump refused to pull him, Democrats would simply delay, finding more accusers and demanding lengthy FBI investigations and more hearings. But Ford's testimony was not credible; filled with inconsistencies.

Despite numerous untruths and conflicts in her statements, we were expected to believe Ford's accusations against Judge Kavanaugh, even though she could not remember the time, date, or place where the supposed assault occurred 36 years ago. All four witnesses Ford provided denied being present at the party she described or even knowing Kavanaugh. There was also poten-

tial witness tampering, obstruction, and possible suborning of perjury committed by a former FBI agent, Monica McLean. She had urged one witness, Leland Keyser, to change her statements, since Keyser had denied being at any party where Ford was assaulted and stated under penalty of felony that she didn't know Brett Kavanaugh.

Wild accusations flew furiously but Kavanaugh remained stalwart, constant in his proclaimed innocence. Through repeated badgering by Democrat committee members, first in their failed sexual assault allegations, then accusations of public drunkenness and "rage" issues, even throwing ice in a bar altercation 33 years ago, the judge stood fast. Politics of personal destruction, administered by the masters of manipulation and deception known as the Democrat Party, failed to claim a victim.

Democrat members of the committee tried every avenue possible to delay the confirmation proceedings, attempting to push them past the election in November. Nothing worked. Kavanaugh refused to cave and, eventually, reason prevailed.

Donald Trump won the presidential election in 2016 because he fights back. Judge Brett Kavanaugh won this confirmation battle in 2018 because he fought back. He defended his character and reputation, his impeccable record, his family's honor, and the Constitution on September 27. ## Descent into madness

### Too close

In a piece titled, "Judicial Wars Are Just Getting Started," Matthew Continetti of the *Washington Free Beacon* wrote, "The reason for these increasingly hard-fought and closely decided Supreme Court battles is that the last four nominees have been originalists and textualists who threaten the progressive doctrine of the Living Constitution. The Left's hold over the Supreme Court is under threat."

Even though a perverted inquisition of an innocent man has failed, the accusations against him will not be swept away. Beginning with Sen. Dianne Feinstein, Democrats have called for further investigation of the allegations against Justice Kavanaugh, his irrelevant college drinking habits, his temperament and demeanor. Some House Democrats, along with a few in the Senate, have even called for Kavanaugh's impeachment (if Democrats retake the House). Democrats are calling his upcoming tenure on the Supreme Court "illegitimate."

The fight over the highest court is far from over, but some in the GOP were up for this battle. After Sen. Lindsey Graham's awesome smack-down of committee Democrats' false accusations of Kavanaugh and his exposure of their obvious political agenda, more Republicans are paying attention. Sen. Susan Collins began to doubt Kavanaugh's accusers. Her speech from the Senate floor on Friday was eloquent and solidly logical, enumerating the reasons she would support his confirmation.

Short-timer Sen. Jeff Flake, mercifully leaving the Senate at year's end, played nice with the demented Democrats, and was responsible for a needless week's delay in the hearings. But he came around, as did all Republicans except Sen. Lisa Murkowski, who voted "present."

At 50-48, the final vote was close. What was "too close" however, was the near disaster of a redefinition of due process pushed by Democrats: Guilty until proven innocent.

Their attack on this foundation of America's criminal justice system through the political assassination of Kavanaugh has seriously energized Republican voters.

Forget about the "blue wave."

The Democrats' plan was to delay Kavanaugh's confirmation, destroy him and his family if need be, to deny President Trump a second Supreme Court seat. They would win November's mid-term elections, taking back a majority in the House and hopefully also in the Senate. Then they could impeach Trump while holding open the Supreme Court seat until they took the White House in 2020. To accomplish this, however, they would need radical activists to create chaos. In stepped the Center for Popular Democracy (George Soros) to sponsor the mayhem against Judge Kavanaugh and the confrontation of senators on Capitol Hill. Shouts of "The system is corrupt and that's why we disrupt!" echoed through office hallways all over the Hill.

Senate Judiciary Committee member Sen. Mike Lee (R-UT) commented on the intensity of the attacks. "I had to be accompanied by police just to walk to the Capitol for votes from my office... it's never been like this."

Sen. Jeff Flake (R-AZ) was the target of a set-up in a Senate office building elevator, cornered by professional progressive activists on a mission to destroy Kavanaugh. Flake succumbed to the intimidation and demanded a *seventh* FBI investigation.

Unhinged leftists from the pro-abortion women's group "Ultraviolet" protested *the courthouse* where Kavanaugh used to work, projecting slogans like "Brett Kavanaugh is a Sexual Predator" in bold letters of light onto the façade of the courthouse building.

Being the only Democrat to vote for Kavanaugh, Sen. Joe Manchin (D-WV) was harassed by a crush of young protesters as he worked his way from the Senate chambers back to his office, pushing past biting shouts of "Shame on you!"

Despite the cloture vote on Friday, Rush Limbaugh noted, "Republican senators are being deluged. Their entire families are being threatened... It's enormous. It is never-ending -- the phones don't stop ringing... It is unhinged, it is vile and it is evil... And they are targeting all the Republicans."

Screaming protesters swarmed Capitol Hill offices as Sen. Dianne Feinstein (D-CA) called Kavanaugh a "violent and dangerous person," a man "filled with anger and aggression," from the Senate podium. She said his behavior "revealed a hostility and belligerence that is unbecoming as someone seeking to be elevated to the United States Supreme Court."

The radical Women's March responded to Sen. Susan Collins' (R-ME) spirited speech, a sober defense of Kavanaugh, with the expected vitriol. Said Linda Sarsour, radical co-chair of the Women's March, in a tweet: "Senator Susan Collins is the mother and grandmother of white women in America who gave us a Donald Trump presidency. The 53 percent. She is a disgrace and her legacy will be that she is a traitor to women and marginalized communities. History will not treat her kindly."

Sophia Benoit from *GQ* magazine tweeted: "If I ever die from getting an illegal abortion, please drop my body off at @SenatorCollins house and let it rot."

Collins' speech also unleashed female celebrity anger. Actress Minnie Driver tweeted: "...Women not believing women. Assuring the rise of toxic masculinity, and giving it a permanent home. I feel utter despair right now..." She went on to state she would fund Susan Collins' "Dem opponent." Molly Ringwald tweeted: "Susan Collins you are a betrayer of women."

Vile comments permeated media. On *MSNBC*, Al Sharpton issued another racist rant: "Let's not forget, these people will go to church and then go to the lynching, after clothing themselves in morality. That's what we're seeing today." Chris Matthews on the same network called for "vengeance" ...for "what happened two years ago."

Mob mentality contains Democrat DNA, and it's been exposed. Voters watched the descent into madness.
